**Overview**

Baylor College of Medicine, The University of Texas MD Anderson Cancer Center and The University of Texas Health Science Center at Houston are honored to nominate Rolanette and C. Berdon Lawrence for the Association of Fundraising Professionals' 2018 Maurice Hirsch Award for Philanthropy. This visionary couple tackles neglected causes to bring hope to many in Houston and across Texas.

Originally from Lake Charles, Louisiana, Berdon has become an integral part of the Houston community with his wife, Rolanette – a native Houstonian. Their support encompasses educational advancement, wildlife conservation, medical improvements and the arts. One of the Lawrences' most distinguished contributions to the medical community was the creation of the Rolanette and Berdon Lawrence Bone Disease Program of Texas (BDPT), which brings together scientists and clinicians from Baylor College of Medicine, MD Anderson Cancer Center and The University of Texas Health Science Center at Houston to foster discovery and improve patient care for those suffering from bone disorders. In their lifetime, the Lawrences have given more than \$31 million to charitable causes and extended their community impact by engaging their children in the philanthropic sphere through their family foundation.

Outside of nonprofit organizations, the Lawrences' kindness extends to employees and family members of employees in need. They have assisted employees facing medical challenges or who require some other form of aid. These unseen gestures have improved the quality of life of many individuals and their families. In times of joy or adversity, the Lawrences always lend a hand to worthy causes that make Houston one of the greatest cities in the United States.

**BAYLOR COLLEGE OF MEDICINE**

1. Rolanette and Berdon have donated more than \$7.4 million to Baylor, primarily to the BDPT, but also to the Best Minds Best Medicine campaign and the cutting-edge McNair Campus, which offers a new model of personalized care for patients.
2. As two of Baylor's top supporters, the Lawrences give much of their time and resources to advance medicine. Berdon has served on the Baylor Board of Trustees for 15 years.
3. The Lawrences' vision allowed Baylor to build on the BDPT's accomplishments by creating the Center for Skeletal Medicine and Biology in 2013 to develop coordinated research, patient care and training opportunities aimed at musculoskeletal health. Their leadership and commitment to Baylor have improved the quality of life for many patients.

**MD ANDERSON CANCER CENTER**

1. The Lawrences have given more than \$3.4 million to MD Anderson Cancer Center. Their philanthropy created an endowment to support the BDPT, which will have an everlasting impact on the study and care of patients with bone disease, particularly bone metastasis – one of the most frequent causes of pain in individuals with cancer.
2. Berdon has been a member of the Board of Visitors since 2004 and currently is a Senior Member. The Lawrences also have hosted numerous activities on MD Anderson's behalf.

3. Gifts from the Lawrences to the BDPT have been a catalyst and inspiration for others who contribute and participate in the bone program. The BDPT also opened the door for MD Anderson to create additional programs, such as the Bone Seminar Series hosted each month at the AT&T Telehealth Center.

**THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT HOUSTON**

1. The Lawrences have donated \$835,333 to UTHealth. Their most recent gift of \$333,000 to the BDPT inspired a 100 percent matching gift from the UTHealth Game Changers Program. These gifts stimulate bone research by encouraging young scientists through diverse bone-related educational activities and grant opportunities.
2. The Lawrences recently participated in the initial feasibility study of the upcoming UTHealth comprehensive campaign.
3. In an effort to strengthen the BDPT, the Lawrences invited UTHealth to participate in the program in 2014. This has allowed UTHealth to develop closer collaborations and relationships with Baylor and MD Anderson and gain access to new cores and resources.

**THE KINKAID SCHOOL**

1. The Lawrences have donated more than \$9.4 million to Kinkaid, transforming its campus and ensuring it remains a top-tier school.
2. Since 1990, Berdon and Rolanette have given much of their time and support to Kinkaid. They enthusiastically lead and volunteer in school activities. In 2009, Berdon joined the Kinkaid Board of Trustees, contributing significantly to the school's strategic decisions.
3. Berdon was an important leader on the Tomorrow's Promise Capital Campaign Committee, which raised more than \$26 million to fund the purchase of a 26-acre lot that enhanced the Kinkaid campus for students. The Lawrences also are consistently among the first to make a commitment or declaration of support for new initiatives. This often encourages other board members to follow suit.

**TULANE UNIVERSITY**

1. The Lawrences have given more than \$4.1 million to fund numerous endowments, chairs, expansion projects, as well as the Lawrence Finance Case Competition.
2. While serving on the Board of Tulane, Berdon chaired the Development Committee during the Promise & Distinction Campaign that raised more than \$730 million. He and Rolanette created the Lawrence Finance Case Competition, now in its 22nd year, which tests the valuation and financial analysis skills of students in a challenging, time-sensitive environment.
3. The Lawrences' contributions have enriched education for countless students and provided a robust learning environment through the construction of new buildings.

**MUSEUM OF FINE ARTS, HOUSTON**

1. The Lawrences have given more than \$2.4 million to the Museum of Fine Arts, Houston (MFAH), and frequently support events that bring entertainment and culture to Houston.
2. Rolanette has been a member of the MFAH Board of Trustees since July 2006. In 2013, the Lawrences chaired the MFAH's Bayou Bend Garden Party. Their hard work

organizing the event drew a crowd of 650 people that raised \$650,000 for Bayou Bend's operating budget.

3. The Lawrences value and promote the MFAH's beautiful works of art through their giving and volunteerism. This allows Houstonians the opportunity to experience works of famous artists and raises the artistic awareness of the Houston community.

**CAESAR KLEBERG WILDLIFE RESEARCH INSTITUTE AT  
TEXAS A&M UNIVERSITY-KINGSVILLE**

1. As avid outdoor enthusiasts, the Lawrences have contributed more than \$638,000 to the Caesar Kleberg Wildlife Research Institute (CKWRI), creating endowments and funding other research initiatives.
2. In addition to Berdon's eight years of service on the CKWRI Board, the Lawrences used their connections to establish a research collaboration between CKWRI and Baylor. With the help of the Lawrences, renowned Baylor geneticist and bone disease specialist Brendan Lee, M.D., Ph.D., partnered with CKWRI to sequence the genome of the white-tailed deer, which holds promising insights for human bone regeneration.
3. The Lawrences' involvement at CKWRI has revived habitats, restored animal populations and provided key research connections for innovative medical treatments.

**Innovation, Creativity and Leadership in Supporting Causes**

Rolanette and Berdon Lawrence breathe life into needed programs. This is especially true of their work in establishing the BDPT in 2002. The BDPT is the only program of its kind in Texas, and today it advances research and promotes activities related to bone health and osteoporosis.

When Berdon was diagnosed with osteoporosis in 2001, he and Rolanette were shocked that there was no organized effort to improve treatment or prevent the disease. The Lawrences realized there was an opportunity for collaboration and launched this effort. They worked for more than a year with Baylor College of Medicine and MD Anderson Cancer Center to create this one-of-a-kind program. At the time, such partnerships were rare. The BDPT set a successful precedent for future collaborations in the Texas Medical Center. Its success can be measured by the increasing number of junior and senior bone scientists and the annual funding from the National Institutes of Health. The program also led to the development of three technology cores, three clinical programs and a clinical program expansion. These breakthroughs were possible through the generosity and entrepreneurial spirit of Rolanette and Berdon Lawrence.

**Encouraging and Motivating Others to Engage in Philanthropy**

The Lawrences have a talent for identifying potential. This applies to the physical world as they care for the environment and to the programs they create to improve life in Houston and beyond. In 2002, they created the Development Advisory Committee, a group of nine individuals that grew to 14 by 2005 to support and advocate for the BDPT. In 2017, they inspired the core BDPT organizations to raise and institutionally match support, resulting in more than \$3.3 million that includes their own donation. With many decades of service and support, their talent has inspired countless others on the boards they serve, the patients they help and the students they aid. Their visionary leadership and passion for important causes continue to shape Houston into one of the world's leading multicultural epicenters.

### **Short Bio**

Rolanette and C. Berdon Lawrence are a Houston power couple that, once they set their minds to a cause, accomplishes anything. As philanthropists, they have touched nearly every cultural sphere in Houston from medicine to the arts, from wildlife to education. Berdon and Rolanette are widely respected leaders and strong supporters of civic affairs. Together, they make a meaningful difference in our community and beyond through their volunteer work and giving.

Important programs have risen from the Lawrences' determination to help others. The Rolanette and Berdon Lawrence Bone Disease Program of Texas, formed in 2002, distinguishes the Texas Medical Center as a leader in bone disease research and treatment. This vital program has led to several breakthroughs in bone health, has acted as a springboard to obtain additional funding and serves as a model for other successful Texas Medical Center partnerships. Further, the programs Rolanette and Berdon have initiated at educational institutions provide opportunities to students who benefit from enhanced learning environments.

The Lawrences and their three children share a passion for improving the world around them that reflects in their philanthropy and commitment to people in need.

## **Long Bio**

Originally from Lake Charles, Louisiana, C. Berdon Lawrence graduated from Tulane University with a Bachelor of Business Administration and an M.B.A. in Finance. Rolanette Lawrence attended Lamar High School and Sam Houston University. Berdon currently is the Chairman of the Board of L3 Partners, LLC, a family business that manages investments and real estate. Previously, he was the Founding President of Hollywood Marine, a privately owned tank barge company that became the largest of its kind in the United States. When Berdon merged Hollywood Marine with Kirby Corporation in 1999, he served as Kirby Corporation's Chairman of the Board until 2010 and Chairman Emeritus from 2011-2012.

Rolanette and Berdon quickly became an integral part of Houston and South Texas as they actively participated in those communities. In addition to supporting their alma maters, the Lawrences took an interest in their children's and grandchildren's education. They became involved as volunteers and donors at The Kinkaid School and other centers of learning around Houston. When Berdon was diagnosed with osteoporosis in 2001, he and Rolanette brought together prestigious medical institutions to form the Rolanette and Berdon Lawrence Bone Disease Program of Texas – the first partnership of its kind in the Texas Medical Center and the only program of its kind in Texas. For this work, Berdon received the 2017 Men of Distinction Award.

As active members of the community, they participate on boards across several organizations. Berdon serves on The Kinkaid Board of Trustees, the Baylor College of Medicine Board of Trustees, the MD Anderson Board of Visitors, The National Osteoporosis Foundation Board and the Caesar Kleberg Wildlife Research Institute Board.

Rolanette serves on the Board of Trustees for the Museum of Fine Arts, Houston, and on the Advisory Board of the Culinary Institute LeNotre. She is a past Trustee of the Houston Museum of Natural Science and The Palmer Drug Abuse Program. As a past board member, Rolanette helped the Houston Museum of Natural Science with many decisions that impacted their organization. She also participated on the executive committee that launched the Cockrell Butterfly Center, an exciting addition to the museum's exhibits.

Together, they were honored as recipients of The H. Rudy Teichman Anchor of Strength Award given annually to a family widely known as compassionate cancer caregivers. Outside of Houston, they are committed to saving and improving the habitats of waterfowl, quail, deer, turkey and dove, and they completely rejuvenated the land on their Laborcitas Creek Ranch near Falfurrias, Texas. Their conservation work has earned them numerous awards and recognitions across Texas, including a Purdey Award, the Lone Star Land Steward Award, the South Texans of the Year and the most recent Leopold Conservation Award.




